Students are admitted into the Elementary Transition to Teaching (T2T) program in the late fall and start their program in the spring semester. The T2T program is no longer a state mandated program. We have chosen to continue the Elementary T2T program and re-design the secondary T2T into "Advance to Teaching (A2T) which will begin fall 2017. Both programs have 24 credit hours. We were able to re-allocate resources and offered a release time to a full-time faculty to coordinate the T2T elementary program starting fall 2015. We will do the same for the Advance to Teaching program.
